Tendering will be conducted through National Competitive Tendering procedures specified in the Public Procurement with Exclusive Preference (Works, Non Consultant and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice No. 97 and is open to all Tenderers as defined in the Regulations..

A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers upon submission of a written application to the address given under paragraph 3 above and upon payment of a non-refundable fee of TZS: 50,000.00. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to TANESCO Ltd. P.O. Box 9024 Dar es Salaam. Bidding documents may be dispatched through courier upon bidder's courier arrangement. The purchaser (client) shall bear no responsibility for late delivery of the bidding documents.

7. All tenders in one original plus three copies, properly filled in, and enclosed in plain envelopes clearly marked "TENDER NO. BOX 9024, DAR ES SALAAM TANZANIA to reach him at room No. G 15 not later than **2nd October, 2009**"**at or before 14.30hrs local time**. Tenders will be opened thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Twiga Board Room located at Ground floor, TANESCO Head Offices, Umeme Park Building, Morogoro Road – Ubungo.
