THE Tanzania National Roads Agency - Coast Region tender for rehabilitation works along Msoga - Msolwa Road, which had been awarded to Del Monte (T) Ltd, will now be implemented as envisaged, after the Public Procurement Appeals Authority (PPAA) dismissed an appeal which had been lodged against it.

According to the proceedings, the Appeals Authority, sitting on 7 October 2022 under Acting Chairperson Adv. Rosan Mbwambo, heard that the restricted national competitive tender worth TZS 6,722,455,700.00 had been advertised through Tanzania National e-Procurement System (TANePS) and that four bidders took part in it, including Bharya Engineering & Contracting Company Ltd who is

the appellant.

The proceedings also show that when the entity sent notices of its intention to award contract to somebody else and not Bharya Engineering & Contracting Company Ltd, the latter felt aggrieved, on discovering that the reasons advanced for his disqualification were invalid and, in the case of one, injurious to his reputation, as it implied

that he had fraudulently cited a non-existing contract to prove requisite experience. He was thus compelled to apply for an administrative review, for which the entity decided upon and upheld its earlier decision.

The proceedings further show that, undeterred, the appellant later successfully sought and got rectification of details in a defect liability certificate from an earlier employer that had led to allegation of fraud. Now, believing that the allegation of fraud had been cleared, wrote to the entity to ask them to reconsider their decision, but they refused, and the aggrieved bidder decided to appeal.

In response, the entity filed a notice of preliminary objection on the point of law that the appeal had been filed out of the prescribed seven days after receiving the response to the application for administrative review, which in turn prompted the appellant's prayer to PPAA that they needed to be heard nevertheless, as the allegation of fraud was serious and could lead to debarment and went on to claim that the hearing would unveil serious illegalities.

However, in the seemingly endless legal tussle between the two protagonists, the entity went on to raise yet another objection to the appellant's prayers, citing some section of the Public Procurement Act that "an application for an extension of time to lodge an appeal out of time shall be filed with the Appeals Authority within seven days from the date when the appellant ought to have filed his appeal using PPAA Form No. 6."

According to the proceedings, the Appeals

Authority agreed with the appellant that it was, in fact, not bound by rules of procedures and evidence as the law said "the proceedings before the Appeals Authority shall be conducted with as little formality and technicality as possible and, in relation thereto, the Appeals Authority shall not be bound by strict rules of evidence or court procedures."

However, the Appeals Authority held that the application for extension of time itself should have been made within seven days from the date the appellant ought to have filed his appeal, which was not done and reached a decision that indeed the application was lodged out of time, and so dismissed both the appeal and the subsequent application for extension of time.

Rushwa katika ununuzi wa umma

■AASISI pamoja na mashirika ya umma ili kutekeleza wajibu na majukumu yao huhitaji kufanya ununuzi wa bidhaa, huduma na kazi. Ununuzi wa umma ni moja va shughuli za serikali zilizo na vihatarishi zaidi vya rushwa. Sababu ya hili ni wingi wa idadi ya shughuli hizo na maslahi ya kifedha, lakini pia vihatarishi vya rushwa katika ununuzi wa umma vinazidishwa na ugumu wa michakato, mwingiliano wa karibu kati ya maafisa wa serikali na wafanyabiashara, na wingi wa wadau wa ununuzi wa umma (OECD, 2016).

Katika viambatisho nambari 4-10, 4-11 na 4-12 vya Ripoti ya Tathmini ya Utendaji wa Mamlaka ya Kudhibiti Ununuzi wa Umma (PPRA) ya mwaka 2021/22 vinaonesha mikataba 48 katika taasisi 30 kati ya 232 zilizofanyiwa tathimini na PPRA, zilikuwa na kiwango kikubwa cha viashiria vya rushwa katika ununuzi wa umma.

Rushwa ni nini?

Kitendo cha rushwa kinatafsiriwa kuwa ni kuahidi, kutoa, kupokea au kushawishi moja kwa moja au kupitia wakala, kitu chochote cha thamani ili kupindisha utaratibu katika utoaji wa maamuzi. Kwa njia moja au nyingine, rushwa huhusiana na udanganyifu ambao unahusisha kutotimiza wajibu, kujitambulisha kwa uongo au jaribio la kupotosha ukweli ili kujipatia faida ya fedha au

manufaa mengineyo. Kwa hiyo, rushwa na udanganyifu huathiri maendeleo ya uchumi wa nchi na ni kikwazo kikubwa katika kupunguza umaskini na kukuza maendeleo. (NACSAP III)

Pamoja na mambo mengine, rushwa katika ununuzi wa umma huweza kuleta madhara ya moja kwa moja kama upotevu wa fedha za umma kwa kufanya ubadhilifu au ununuzi kwa bei isiyoendana na soko, na kununua bidhaa, huduma au kazi zenye ubora hafifu. Mara nyingi wanaotoa rushwa hurejesha fedha zao kwa kupandisha bei, kushindwa kufikia viwango vya mkataba, kupunguza ubora wa kazi au kutumia vifaa duni.

Vilevile, Kwa upande wa madhara yasiyo ya moja kwa moja, rushwa katika ununuzi wa umma husababisha upotoshaji wa ushindani, upatikanaji mdogo wa soko na kupunguza hamu ya kibiashara kwa wawekezaji wa kigeni.

Vyanzo vya rushwa katika ununuzi wa umma

Rushwa katika ununuzi wa umma husababishwa na ukosefu wa maadili katika michakato ya ununuzi tangu hatua ya uandaaji wa mahitaji, awamu ya zabuni, utekelezaji wa mkataba na hata mpaka hatua ya malipo.

Vifuatavyo ni baadhi ya vihatarishi vya ukosefu wa maadili katika mchakato wa ununuzi vinavyopelekea rushwa

- i.) Ukosefu wa tathmini ya kutosha ya mahitaji
- ii.) Ushawishi wa watendaji wa nje juu ya maamuzi ya mahitaji

- iii.)Makubaliano ya awali ya mkataba baina ya taasisi nunuzi na mzabuni
- iv.) Uandaaji wa mpango kazi usioendana na uhalisia wa bajeti
- v.) Uandaaji wa vipimo vya mahitaji (specifications) vinavyoilenga kampuni fulani
- vi.) Ukiukwaji wa taratibu zilizopangwa kisheria kwa matumizi ya njia za ununuzi zisizo za ushindaji mfano matumizi mabaya ya uharaka uliokithiri (emergency procurement) na mgawanyo wa mikataba (contract splitting) na matumizi ya "Force Account" katika shughuli za ujenzi.
- vii.) Ukosefu wa sababu sahihi (justifications) za matumizi ya njia zisizo za kiushindani mfano Single Source Procurement na Restricted tendering.
- viii.) Kutokuwepo kwa tangazo kwa umma juu ya mwaliko wa zabuni husika na kutotangazwa kwa vigezo vya tathmini na tuzo za zabuni hizo
- ix.) Ukosefu wa ushindani au uwepo wa "collusive bidding" (cover bidding, bid suppression, bid rotation, market allocation)
- x.) Uwepo wa mgongano wa maslahi wakati wa kufanya tathmini kutokana na kuwepo kwa uhusiano na mzabuni au Maslahi ya kibinafsi kama vile zawadi au matumizi ya baadaye.
- xi.) Mzabuni kutotoa taarifa sahihi ya gharama au bei katika mapendekezo yao ya bei, hivyo kusababisha ongezeko la bei wakati wa mkataba na ukosefu wa upatikanaji wa kumbukumbu za utaratibu uliotumika
- xii.) Ukiukwaji wa mzabuni katika kutekeleza mkataba, haswa katika suala la ubora, bei na muda

mfano kuwepo kwa:

- Mabadiliko makubwa katika masharti ya mkataba ili kuruhusu muda zaidi au bei ya juu zaidi kwa mzabuni
- Ubadilishaji wa bidhaa au kazi ya chini ya kiwango au huduma isiyokidhi mahitaji ya mkataba
- Wizi wa mali mpya kabla ya kuwasilishwa kwa mtumiaji wa mwisho au kabla ya kurekodiwa
- Usimamizi hafifu wa maafisa wa taasisi husika au kuwepo kwa njama baina ya wakandarasi na maafisa wanaosimamia.
- Kutokuwajibishwa kwa wakandarasi wadogo (subcontractors) na washirika waliochaguliwa
- xiii.) Kutokuwepo kwa mgawanyo mzuri wa majukumu ya kifedha au ukosefu wa usimamizi mzuri kwa maafisa wa fedha katika taasisi nunuzi kunaweza kupelekea:
- Uhasibu potofu na mgao potofu wa gharama au uhamishaji wa gharama kati ya mikataba;
- Ucheleweshwaji wa malipo ya ankara;
- Uwepo wa ankara za uwongo au zilizojirudia au kwa bidhaa na huduma ambazo hazijaletwa.

Namna ya kukabiliana na rushwa katika ununuzi wa umma

Kama inavyotambuliwa na kifungu cha 5 cha UNCAC, kanuni za msingi zinazohusiana na kuzuia rushwa katika sekta ya umma ni utawala wa sheria, usimamizi sahihi wa masuala ya umma na mali ya umma,

Kanuni za Maadili (Codes of Conduct)

Ili kuzuia rushwa katika ununuzi wa umma ni muhimu kuanzisha, kuboresha na kuzishurutisha sheria na kanuni zinazozuia mienendo na tabia fulani kwa watumishi wa nyanja zote serikali na binafsi. kanuni hizo zijumuishe makatazo na adhabu kwa walengwa. Kulingana na kifungu cha 8 cha UNCAC, kanuni hizo zinapaswa kutumika kuhamasisha kukuza viwango binafsi vya mlengwa

(yaani uadilifu, uaminifu na uwajibikaji) na utekelezaji wa majukumu ya kitaaluma kwa usahihi, utendaji usio na upendeleo, heshima na usahihi. Kanuni hizo zitoe mwongozo wa jinsi watumishi wa umma wanapaswa kujiendesha kulingana na kanuni hizo na jinsi wanavyoweza kuwajibika kwa matendo na maamuzi yao.

Vilevile, taasisi nunuzi zinapaswa kutekeleza kwa ukamilifu Mpangokazi wa Mkakati wa Taifa dhidi ya Rushwa (NACSAP III) ikiwa ni pamoja kuzijengea uwezo Kamati za Kudhibiti Uadilifu ili ziweze kutekeleza majukumu yake kwa ufanisi zaidi.

Upatikanaji wa zabuni (Accessibility)

Hii inahusisha uwezo wa makampuni yote kupata fursa za zabuni za serikali (OECD, 2016). Uwezo wa upatikanaji wa zabuni unahitajika ili kuongeza ushindani katika ununuzi wa umma na kukuza ushiriki wa makampuni madogo na ya kati (SMEs) katika ununuzi wa umma. Upatikanaji huo utapunguza urasimu wa asili katika mchakato wa zabuni, kupunguza gharama za ushiriki katika ununuzi wa umma na kurahisisha mchakato wa zabuni. Upatikanaji wa zabuni za umma kwa makampuni madogo na ya kati (SMEs) na makampuni mengine lengwa yanaweza kuwezeshwa na sheria zinazotaka sehemu ya zabuni za serikali kupewa viwanda vidogo na vya kati pamoja na Makundi Maalum yaani kuwepo kwa upendeleo maalum.

Usimamizi wa rasilimali watu

Sheria na taratibu za kuajiri, kuzungusha (rotation), kupandishwa vyeo, taaluma, na mafunzo ya watumishi wa umma pia yana mchango mkubwa katika kupambana na rushwa katika ununuzi wa umma.

Vitengo vya vinavyosimamia ununuzi wa umma vinapaswa kuundwa na watumishi kwa kiwango kinachofaa (kama

kinavyoongoza kifungu cha 37 cha Sheria ya Ununuzi wa umma ya mwaka 2011) na kiwe na watumishi wenye taaluma ya ununuzi/ugavi waliosajiliwa na Bodi ya Wataalamu wa Ununuzi na Ugavi (PSPTB) ili kusimamia taaluma zao.

Vile vile kwa maeneo ambapo ununuzi wake una vihatarishivikubwa vya rushwa (corruption vulnerable areas), ni vyema kufanya "staff rotation" ili kusaidia kuzuia mahusiano ya rushwa yasijenge na kuvuruga mahusiano ya rushwa yaliyoanzishwa.

Muhimu zaidi ni suala la uadlifu kwa watumishi wa umma, kama kifungu cha 7 cha UNCAC kinavyoelekeza, kuwa mfumo wa usimamizi wa rasilimali watu wa utumishi wa umma lazima uzingatie misingi ya uwazi, uadilifu na ufanisi.

Mfumo Madhubuti wa Kielektroniki wa Ununuzi wa Umma (E-procurement system)

Mfumo madhubuti wa ununuzi wa umma wa kielektroniki utasaidia sana kuzuia uwezekano vya vitendo vya rushwa kwenye ununuzi kwa kuwa unahimarisha uwazi, upakatikaji wa zabuni na unarahisisha taratibu za kiutawala katika mchakato mzima wa ununuzi.

Mfumo madhubuti wa kielektroniki wa ununuzi wa umma hupunguza mwingiliano wa moja kwa moja kati ya maafisa wa ununuzi na makampuni na kuruhusu urahisi kugundua kasoro na viashiria vya rushwa, kama vile mipango ya wizi wa zabuni (bid rigging schemes) lakini pia hutoa njia

za huduma za ukaguzi ambazo zinaweza kuwezesha shughuli za uchunguzi.


Kusimamia migongano ya maslahi

Migongano ya maslahi inaweza kusababisha rushwa, kwa hivyo inahitaji kuwekwa wazi na kushughulikiwa kwa namna ambayo itazuia rushwa. Kwa ujumla, Migongano ya maslahi hushughulikiwa kwa kuweka utaratibu wa kutangaza uwepo wake kabla ya kuanza michakato ya ununuzi na hasa katika hatua ya kufanya tathmini ya zabuni. Kifungu cha 40 (6) cha sheria ya ununuzi wa umma ya mwaka 2011, kinawataka wajumbe wa kamati ya tathimini kusaini fomu ya maadili itawataka kutangaza kuwa hawana mgongano wa maslahi na hitaji la ununuzi husika.

Ufuatiliaji na Uangalizi

Mamlaka ya kudhibiti Ununuzi wa Umma iendelee kufanya ukaguzi wa shughuli za ununuzi na kuzitangaza taasisi zilizozifanya vibaya katika ukidhi wa sheria ya Ununuzi (To establish a list of shame). Pia kuwasilisha taarifa TAKUKURU juu ya uwepo wa viashiria vya rushwa vya kiwango cha juu kwenye michakato ya ununuzi, kwa hatua zaidi.
