ALL key methods of public procurement can now be implemented through Tanzania National e-Procurement System, following inclusion of minor value procurement method, TPJ can report.

Speaking during training on TANePs to staff responsible for public procurement in procuring entities, which was held recently in Mwanza, PPRA's Principal Systems Administrator, Mr. Mapinduzi Muhochi, said now there is no excuse to conduct tender processes out of the system, including the procurement of minor value.

He further said that the inclusion of minor value procurement in TANePS will enable the government to know the total number of tenders which will, in turn,

facilitate monitoring and evaluation of tenders in a shorter time.

"This is the reason for offering training on minor value procurement in TANePS to procuring entity personnel involved in procurement

Unfairness, alien criteria discredit decision to disqualify bidder -PPAA

Limited which was contesting the grounds used by RAS-Singida to disqualify its bid, PPAA faulted the procuring entity in the way it conducted the procurement process, finding it necessary to remind entities that they needed to always strive to achieve the highest standard of equity, taking into account equality of opportunities to tenderers, fairness, and with an eye on obtaining value for money.

According to the decision dated 1 April 2021, the entity had sent notice to inform him that their tender was disqualified because it did not meet requirements on various certificates.

Claiming that the stated requirements were alien criteria, meaning they were not in the tender document, General De Pharmacy Limited applied for administrative review - for which the entity failed to respond thereby pushing him to lodge the appeal. In particular, the appellant was adamant that the requirement to submit certified copies was only stated in the Tanzania e-Procurement System (TANePS), which he deemed not to be part of the tender document, and that the document itself was ambiguous whereby at one point tenderers were not allowed to tender for more than two lots while at another they were allowed for more than one lot.

However, the procuring entity submitted that since the tender was floated through TANePS, it was to be understood by tenderers that the system was part of the tender document and that the stated requirements therein were to be complied with.

In addition, the entity submitted that the appellant had attached tax clearance certificate that indicated he was a retailer instead of wholesaler. It also raised that the application for administrative review had been rendered invalid by a regulation which stipulated that such application did not apply to complaints submitted in response to notice of intention to award.

After the Public Procurement Appeals Authority had reviewed all tendering documents, it discovered unfairness in that the appellant was disqualified for not meeting a requirement that was not in the tender document while the same was also not met by the proposed winner.

Another instance of unfairness was that while the appellant had indeed submitted certified copies of the required certificates the proposed winner had failed to do so, preferring instead to attach uncertified copies.

Furthermore, the Appeals Authority found that the entity's other ground for disqualifying the appellant, namely that the appellant did not attach tax clearance certificate for wholesale business, was invalid as the requirement was not in the tender document, a fact which was given weight by the bids of proposed winners – whose tax clearance certificates showed they were retail business just like the appellant.

It is also apparent that the Appeals Authority was at a loss to find reason which made the entity fail to disqualify both the appellant and the proposed winner on the grounds that both did not adhere to a requirement that they should not tender for more than two lots.

Regarding TANePS, the Appeals Authority agreed with the appellant that the entity was wrong to add a requirement prescribed in the system which was not in the tender document, and ruled that disqualifying the appellant while qualifying others based on the criteria that was not in the tender document contravened the public procurement law.

The Appeals Authority went on to nullify the disqualification of the appellant's tender and ordered the entity to restart the tendering process in compliance with the law.

Mwongozo wa Force Account unamtaka afisa masuuli kumteua meneja au msimamizi-mradi kwa mradi husika. Meneja huyo atateuliwa kwa kuzingatia fani, utaalamu na uzoefu unaohitajika kwa mradi ule na atapaswa kuwa mtu aliyesajiliwa katika fani ya uchoraji, ukadiriaji majenzi au uhandisi.

Majukumu ya meneja ni pamoja na kupitisha mpangokazi wa ujenzi kabla haujaanza kutekelezwa; kusimamia ujenzi huo; kupima na kuthibitisha ujenzi unaofanyika pamoja na gharama zake; kuthibitisha ujenzi uliokamilika; na kusimamia timu ya utekelezaji mradi.

Meneja ndiye msimamizi mkuu wa mradi wa Force Account kwa upande wa utaalamu, huku afisa masuuli akiwa msimamizi mkuu kiutawala.

B. Timu za Utekelezaji na Usimamizi

Afisa masuuli anatakiwa kuteua timu mbili: ya utekelezaji wa mradi na ya usimamizi na wajumbe wa timu hizo watapendekezwa na mkuu wa idara ya ufundi; wajumbe hao wanapaswa kuwa na fani, uzoefu au ufundi katika masuala ya ujenzi.

Majukumu ya timu ya utekelezaji ni pamoja na kuanisha vifaa, mashine na mitambo kwa ajili ya ujenzi huu, kuandaa mpangokazi wa ujenzi, kupanga wahusika wa kutekeleza kazi za ujenzi, kusimamia eneo la ujenzi, kuandaa mikataba ya vibarua na kutekeleza ujenzi kama anavyofanya mkandarasi.

Majukumu ya timu ya usimazi ni pamoja na kufuatilia utekelezaji wa mradi kwa mujibu wa mpangokazi, ubora na bajeti iliyowekwa; kuhakikisha taratibu na sheria husika zinafuatwa; kupima na kuthibitisha kazi za ujenzi zilizofanyika; kuidhinisha malipo yanayohusiana na utekelezaji wa ujenzi; kusimamia mikataba ya ujenzi na kuandaa ripoti za maendeleo ya mradi.

Timu hizi zinapaswa kufuatilia na kutoa taarifa ya vihatarishi vyote vinavyoweza kusababisha mabadiliko ya gharama, muda na ubora wa kazi ili hatua za kurekebisha zichukuliwe mapema.

Mabadiliko yoyote yatakayohusiana na muda, gharama, ubora au viwango vya kazi, yanapaswa kuombewa kibali kwenye bodi ya zabuni kupitia afisa masuuli kabla ya kuyatekeleza.

C. Utunzaji wa Kumbukumbu

Taasisi inapaswa kutunza kumbukumbu za:

- i.) Mipango ikiwemo ya ununuzi, mpangokazi wa ujenzi, michoro ya ujenzi, bajeti au makisio ya gharama za ujenzi na mpango wa usimamizi wa ubora
- ii.) Nyaraka za ununuzi zilizotumika kununua nguvukazi, vifaa, mashine na mitambo ya ujenzi, zikiwemo zilizoainisha mahitaji ya ununuzi na kuomba zabuni kutoka kwa wazabuni, zabuni zilizowasilishwa, barua za uteuzi wa kamati za ufunguzi na tathmini, ripoti za ufunguzi na tathmini za zabuni, mihtasari ya kamati za majadiliano (kama yaliyafanyika) na mihtasari ya bodi ya zabuni na barua za tuzo za zabuni

- iii.) Mikataba ya ununuzi wa nguvukazi, vifaa, mashine na mitambo ya ujenzi ikiwemo vigezo msawazo (specifications), michoro na nyaraka nyingine zinazopaswa kuambatishwa kwenye mikataba
