The Public Procurement Appeals Authority (PPAA) has endorsed the decision of Tanzania Institute of Education (TIE) to disqualify a bidder for not meeting the requirement, TPJ can report.

According to the decision of 22 May 2023, English Press Limited, the aggrieved bidder,

decision, explaining that the sample books submitted were not published by the appellant – a claim he disputed and so decided to lodge the appeal, citing unfairness and a lack of transparency. In particular, he was aggrieved that he was disqualified on account of some criteria which had been introduced later on by way of a clarification.

The appellant also stated that the administrative review had given a new reason for the disqualification, namely that the books were not published by the appellant and that it was unfair to disqualify his tender as it had the lowest price.

In addition, he claimed that the requirement of publishing was not related to the tender which was for printing and supplying textbooks, and that it was not

stated directly in the tender documents.

In its reply, TIE said that the tender document comprises several sections which should be read together and not in isolation, highlighting a clause in the Instruction to Tenderers which specified, among others, a requirement that tenderers should submit sample pages of textbooks published, printed and supplied by them in Tanzania and that the appellant's books were in fact published by TIE.

In addition, the entity stated that claims about the price were irrelevant as their tender did not reach the financial evaluation stage and that what he perceived to be two different reasons for disqualification in the notice of intention to award and in the administrative review decision were, in meaning, the same.

Furthermore, TIE said the clarification did not introduce new criteria but simply gave the reason for the criterion of the

Hatua za kufuata ili kuomba zabuni katika taasisi za Umma

kutojihusisha na zabuni za umma zipo nyingi ikiwemo baadhi ya wafanyabiashara kutofahamu fursa hizo, wengine kukosa uwezo wa kifedha, rasilimali watu na uzoefu na wengine kuogopa changamoto za kuomba zabuni na utekelezaji wa mikataba.

Lakini wapo wafanyabiashara wengi ambao wamekuwa wakiomba zabuni za ummanawamepatamafanikiomakubwa kwa upande wa kifedha na uzoefu.

Michakato ya zabuni za umma ndiyo inafanikisha upatikanaji wa: - madawa na vifaa tiba katika vituo vya afya, vyakula na vitabu mashulenii, bidhaa mbalimbalyavakula, nishatizamafuta, umeme na gesi, maji safi, miundombinu ya barabara, hospitali, shule, viwanja vya ndege, masoko nakadhalika.

Hivyo kwa mfanyakishara kuhusika katika kuomba zabuni na kutekeleza mikataba ya ununuzi wa umma ni kuwa sehemu ya kujenga uchumi wa nchi kuitia kutoa ajira, kulipa kodi na kuwezesha upatikanaji wa bidhaa, huduma na miundombinu inayohitajiwa na umma.

Kwa namna ambavyo wazabuni duniani kote wamekuwa ni sehemu muhimu ya maendeleo ya kijamii na kiuchumi, serikali zimebadili mtazamo na kuwaona wazabuni kuwa ndiyo waendesha uchumi (economic operators) na washirika muhimu katika kuleta maendeleo kuitia ununuzi wa kawaida na ule wa utaratibu wa ubia baina ya sekta ya umma na binafsi.

Kwa jinsi ambavyo soko la ununuzi wa umma lilivyo kubwa hata wazabuni

kutoka mataifa ya kigeni wamekuwa wakiomba zabuni za umma, na ukweli ni kwamba baadhi ya makampuni ya wazabuni hao yanamilikiwa na serikali, majeshi au makampuni makubwa katika nchi zao.

Jambo hili lina maanisha kuwa soko la zabuni za umma ni soko la kimataifa, tena lenye kuvutia mpaka makampuni yanayomilikiwa na serikali.

Kwa kuwa jukumu kubwa la serikali ni kutoahudumakwananchi wake na kujenga mazingira wezeshi ya kuchochea shughuli za kiuchumi na kijamii, serikali nyingi duniani huachia sekta binafsi shughuli za uzalishaji wa bidhaa, utoaji wa huduma na ujenzi wa miundombinu. Pamoja na kwamba serikali hujijengea uwezo wa ndani wa kutimiza baadhi ya mahitaji yake, lakini sehemu kubwa ya mahitaji hayo hununuliwa kutoka sekta binafsi kuitia michakato ya ununuzi.

Michakato ya ununuzi inahusisha hatua za: - kutambua mahitaji ya ununuzi; kupanga bajeti na mipango ya ununuzi; michakato wa zabuni; na kuandaa, kutoa na kusimamia mikataba ya ununuzi.

Kwa kuangalia hatua za mchakato wa ununuzi, utaona kuna hatua moja muhimu nayo ni mchakato wa zabuni ambayo inahusisha taasisi nunuzi kutangaza fursa za ununuzi walizonazo ili wafanyabiashara wawasilishe zabuni zao kuomba kusambaza bidhaa, kutoa huduma au kujenga miundo mbinu.

Neno zabuni limekuwa likitumika sana, na mara nyingine halitumiki katika maana yake sahihi. Kimsingi zabuni ni mapendekezo ya bei yanayowasilishwa na mfanyakishara kama mwitikio wa mwaliko

wa taasisi nunuzi kusambaza bidhaa, kutoa huduma au kujenga miundo mbinu.

Kwa hiyo, siyo sahihi kusema taasisi nunuzi wanatoa zabuni badala yake wanatangaza fursa kwa wafanyabiashara kuwasilisha zabuni zao kwa ajili ya kutimiza mahitaji ya taasisi nunuzi. Fursa za kuwasilisha zabuni hutangazwa na taasisi nunuzi kupitia nyaraka za zabuni ambazo zinaitwa hivyo kwa sababu zinaeleza mahitaji ya taasisi nunuzi na kuelekeza taratibu za kufuatwa ili mfanyakishaa aweze kuwasilisha zabuni yake.

Kama zilivyo fursa zingine za kiuchumi, fursa za zabuni za umma si fursa za kuchukua tu, bali zinahitaji kuijandaa, kuingia na kukabiliana na changamoto zinazoweza kujitokeza. Ili kuhakikisha soko hili linakuwa la manufaa kwa serikali na wafanyabiashara, soko la ununuzi wa umma linaendeshwa kwa mujibu wa sheria, kanuni, miongozo na mikataba ya ununuzi wa umma.

Pale ambapo taasisi za serikali zinazingatia taratibu zilizowekwa katika kuandaa bajeti, kupanga ununuzi na kuendesha michakato ya zabuni, zinatoa hakikisho kuwa zitanunua bidhaa, huduma au miundombinu iliyotengewa bajeti na pia wazabuni wanauhakika wa kulipwa kwa kuwa bajeti imetengwa na mikataba imeingiwa kwa kufuata taratibu sahihi.

Ili kuweza kuomba zabuni za umma unaweza kufuata hatua zifuatazo:

a) Amua aina ya biashara unayotaka kufanya na serikali

Kwa wale ambao bado hawajafungua biashara au hata wale ambao tayari wanafanya biashara, ni vizuri kupitia katika tovuti mbalimbali zinazotangaza fursa za zabuni za umma, ili kupata ufahamu wa

fursa zinazotangazwa na taasisi za serikali, ambazo fursa hizo ndiyo aina ya biashara ambazo unaweza kufanya na serikali.

Pamoja na kwamba taasisi za serikali zinanunua vitu vingilakini hazinunui baadhi ya vitu, hivyo iwapo unafanya biashara ambayo siyo fursa serikalini, unaweza kuchagua kufanya biashara nyingine.

Kwa kawaida serikali hununua vitu vikubwa vitatu, ambavyo ni bidhaa, huduma na kazi za ujenzi. Huduma na bidhaa ndiyo hununuliwa mara kwa mara na taasisi za serikali, kazi za ujenzi hununuliwa mara chache kwa mwaka lakini ndiyo hutumia fedha nyingi zaidi.

Ni rahisi kuingia katika kuomba zabuni za bidhaa kwa sababu hazihitaji uzoefu mkubwa, elimukubwa wala mtajimkubwawa fedha (ingawa inategemea na aina bidhaa na ukubwa wa biashara unayotaka kuwa nayo).

Zabuni za huduma zisizo za ushauri elekezi kama huduma za usafi, ulinzi na matengenezo zinahitaji kuwa na watu wenye ujuzi wa kutosha kutoa huduma na mtaji wa kununulia vifaa vya kutolea huduma.

Zabuni za huduma za ushauri elekezi zinahitaji kuwa na wataalamu wa fani husika na vibali kutoka bodi za kitaaluma.

Zabuni za ukandarasi au ujenzi zinahitaji kuwa na wataalamu na vitendea kazi vya kufanikisha ujenzi ambavyo vinaweza kumilikiwa au kukodiwa.

b) Sajili biashara katika mamlaka za usajili

Hapa kuna swali la kujiuliza, je unapaswa kupata maarifa kwanza ndiyo ukajisajili au ujisajili ndiyo ukapate maarifa ya namna kutekeleza zabuni husika?

bidder to be publisher of the books because those who were knew the quality needed by the entity.

TIE submitted that the appeal was devoid of merits and prayed that the Appeals Authority dismiss the appeal with costs.

The Appeal Authority agreed with the appellant that there were indeed two different reasons for disqualification, one stated in the notice of intention to award and the other in the administrative review decision. However, the Appeal Authority also stated that

the reason for disqualification was clearly for the failure to comply with a clause in the tender data sheet and that the appellant had not been prejudiced by that omission.

The Appeal Authority also agreed with the entity's argument that had the appellant found that the said requirement was irrelevant, they should have sought clarification about it or should have challenged its existence by way of administrative review.

However, it found that contrary to the appellant's claim, the requirement for publishing was one

of the criteria in the instruction to tenderers criteria and that the sample text books they submitted were indeed published by TIE.

The Appeals Authority also cast away the appellant's argument on the lowest price since the Appellant's tender did not reach the financial evaluation stage where it could have been compared with others.

The Appeals Authority concluded that the disqualification of the Appellant's tender was justified and dismissed the appeal but without awarding costs to the entity.

Kwa zabuni za ushauri elekezi, mamlaka za usajili wa biashara hudai leseni au vyeti vya kutoka kwenye bodi

za kitaaluma ili kuthibitisha kuwa mtoe huduma ni mtaalamu katika fani husika. Kwa ajili ya kuomba zabuni hizi unaweza kusajili jina la biashara, kampuni, kikundi maalumu au kujisajili kama mtu binafsi.

Kwa zabuni za ujenzi, utapaswa kupata usajili wa bodi za kitaaluma na kisha kusajiliwa na mamlaka za usajili wa biashara. Kwa ajili ya kuomba zabuni hizi unaweza kusajili jina la biashara, kampuni, kikundi maalumu au kujisajili kama mtu binafsi.

Mamlaka kubwa mbili zinazosajili biashara ni BRELA pamoja na TAMISEMI kupitia halmashauri mbalimbali nchini.

c) Sajili biashara yako kama mzabuni katika mifumo ya ununuzi

Ili kuweza kuona na kuomba fursa mbalimbali za zabuni za umma, unapaswakusajili biasharayakokatika mifumo ya ununuzi. Kimsingi usajili

huu, unamtaka mzabuni kuthibitisha kama amekidhi matakwa ya nchi ya kumruhusu kujihusisha na biashara anayotaka kufanya na serikali.

Kupitia mifumo hii ya ununuzi utaweza kuona fursa za zabuni na kuomba, na iwapo utashinda basi utapata taarifa ya ushindi wako kwenye mifumo hii.

Jambo la muhimu ni kuhakikisha unasoma kwa makini masharti ya zabuni, unaelewa mahitaji ya taasisi nunuzi, masharti ya mkataba na kutoa mapendekezo yako ya bei yenye uhalisia kuendana na viwango vya bidhaa, huduma au ujenzi unaohitajika, gharama na muda wa utekelezaji mkataba.
