The Government has introduced a new e-public procurement system and urged stakeholders to register for its use soonest, TPJ can report.

In his opening remarks at a six-day training about the use of the system in Iringa on 26 June 2023, Permanent Secretary to the Ministry of

Information, Communication and Information Technology, Mohammed Abdulla, said the new system known as NeST, is an important tool in ensuring attainment of value for money in public procurement, a sector where 70 percent of the government budget is spent. “The building of this system started on July 18, 2022, and that already two modules, namely e-registration and e-contract are now operational, thereby enabling registration of users for provision of goods and services, and in preparation of annual procurement plans up to awarding of contract,” he said. The permanent secretary added that the two modules are among the six needed for a fully e-procurement process,

including e-contract management, e-catalogue, e-auction and e-payment.

According to him, NeST would increase efficiency, transparency and accountability on top of enabling the Government to get genuine information from bidders "as it is integrated with other government systems."

"Every step in the system reduces human interaction during the tendering process, thereby helping to ensure fair competition," he said.

Mr. Abdulla said after 31 October 2023, all procuring entities will be using NeST for public procurement processes, although there will still be a last window of TANePS for tender processes which will be ongoing. "However, the Government will stop using TANePS on December 31, 2023,"

he said and called upon all stakeholders to ensure they train effectively on the new system in readiness for this eventuality.

Mr. Abdulla also said he was glad that NeST was built by Tanzanians, "who have shown that Tanzania can stand out in the world of technology."

"I commend PPRA for the 'we can do it' initiative, which runs contrary to the mindset of entrusting any complex undertaking to foreigners."

At an occasion to introduce NeST to the public in Dodoma on 23 June, 2023, PPRA Board Chairperson, Dkt. Leonada Mwangike, had said 101 procuring entities would start using NeST Phase One, from 1 July to 1 October 2023.

She went on to call upon stakeholders to register and use the system which, she said, has a mobile application which can be accessed through Play Store and Apple Store.

Mchakato wa Ununuzi wa mashine za Reli, Ndege na Meli Zilizotumika

Taasisi nunuzi inaruhusiwa kufanya ununuzi wa mashine za reli, ndege na meli zilizotumika iwapo maslahi ya taifa yanataka vitu hivyo vinunuliwe kwa utaratibu wa kawaida au kupitia ununuzi wa dharura.

Katika mazingira ya kawaida, suala la upya au utumikaji wakinachonunuliwa linaweza kuongelewa katika ununuzi wa bidhaa na miundo mbinu pekee na si katika ununuzi wa huduma za ushauri elekezi na zisizo za ushauri elekezi.

Viwango vya ununuzi wa umma vinataka bidhaa au miundo mbinu inayonunuliwa iwe mipya kwa maana ya kutokuwa imetumiwa na watu wengine kabla ya kununuliwa na taasisi nunuzi.

Suala la ununuzi wa miundo mbinu inayosaidia kutoa huduma za msingi kwa jamii kwa mfano barabara, reli, hospitali na mingine kama viwanda ikiwemo majengo na mitambo ya uzalishaji linaweza kufanyika kwa taratibu za ununuzi wa kawaida au ununuzi wa ubia baina ya sekta ya umma na binafsi.

Ununuzi wa kawaida au ubia unafaa pale ambapo miundo mbinu inayohitajika haikuwahi kuwepo hivyo inapaswa kujengwa, kanuni za ununuzi kwa sasa hazielezi taratibu

zinazopaswa kufuatwa iwapo serikali inahitaji kununua miundo mbinu ambayo ilishajengwa na sekta binafsi.

Kwa upande wa bidhaa, ili kukidhi maslahi ya taifa hasa katika sekta ya uchukuzi, sheria na kanuni za ununuzi wa umma zimeruhusu ununuzi wa mashine za reli, ndege na meli zilizotumika. Bidhaa hizo pekee ndiyo zinazoruhusiwa kununuliwa hata kama zimeshatumiwa na watumiaji wengine.

Sheria na kanuni tajwa zimeeleza mambo ya kuzingatia kabla ya kufikia maamuzi ya kununua mashine za reli, ndege na meli zilizotumika ili kuondoa kihatarishi cha kununua bidhaa zisizo na tija kwa serikali, taasisi nunuzi na watumiaji wa mwisho.

Wapo watu ambao wamekuwa wakitaka pasiwe na ruhusa ya kununua bidhaa yoyote iliyotumika na wengine ambao wanaomba wigo uongezwe ili kuruhusu ununuzi wabaadhiya mashine, mitambo na vipuri vilivyotumika.

Lakini suala la ununuzi wa kitu kipya au kilichotumika unategemea malengo ambayo kama nchi imejiwekea na inataka kuyafikia katika kudhibiti ubora wa bidhaa, kulinda au kuchochea ukuaji wa viwanda vya ndani na kuweka hadhi ya serikali, viongozi, watumishi na wananchi wake.

Katika makala hii maneno 'mashine au mitambo iliyotumika' litamaanisha 'mashine za reli, ndege na meli zilizotumika' na si vinginevyo.

Kabla ya kuamua kununua

mashine au mitambo iliyotumika, taasisi nunuzi inapaswa: -

i) Kulinganisha faida za kununua moja kwa moja dhidi ya zile za kukodi; mashine au mitambo iliyotumika inaweza kukodiwa iwapo maslahi ya taifa yatamizwa vizurizaidi kwakukodi badalaya kununua moja kwa moja.

ii) Kufanya utafiti na uchunguzi wa kutosha wa soko la mashine au mitambo iliyotumika ili kufahamu wauzaji, mahali walipo, masharti yao na bei za bidhaa husika.

iii) Kuomba ruhusa ya Waziri wa Fedha na Mipango kabla ya kuamua kununua au kukodi.

A. Vigezo vya kuamua kununua mashine au mitambo iliyotumika dhidi ya mpya

Kwa mujibu wa kanuni za ununuzi wa umma, taasisi nunuzi inapaswa kulinganisha faida za kununua mashine za reli, ndege na meli mpya dhidi ya faida za kununua au kukodi zilizotumika katika vipengele vifuatavyo: -

i) Uwepo na uwezo wa wazalishaji, wauzaji, watoa huduma za matengenezo na upatikanaji wa vipuri vya mashine au mitambo iliyotumika ukilinganisha na mpya. Uwepo na uwezo mzuri wa wazalishaji, wauzaji au watoa huduma unatoa hakikisho kwa taasisi nunuzi juu ya kupata msaada wa kiufundi wakati utakapohitajika.

ii) Muda wa matumizi (life expectancy) uliobaki wa mashine au mitambo iliyotumika ukilinganisha na mpya. Muda uliobaki unapaswa kulinganishwa na kipindi ambacho taasisi nunuzi inategemea kutumia mashine au mitambo husika.

iii) Gharama za kununua mashine

au mitambo mpya dhidi ya iliyotumika kwa kulinganisha bei za wauzaji angalau watatu. Ni wazi bidhaa zenye vigezo msawazo tofauti (specifications) zitakuwa na bei tofauti, ili kufikia maamuzi sahihi ni vizuri kuangalia gharama zote za ununuzi ikiwemo bei ya bidhaa, usafirishaji, bima, matengenezo, vipuri na gharama zingine kwa kipindi chote ambacho mashine au mtambo unategemewa kutumika.

iv) Hatari za kiafya kwa watumiaji na za kiusalama katika uendeshaji wa chombo zinazotokana na matumizi ya mashine au mitambo iliyotumika. Ili kudhibiti hatari hizi na nyingine mashine au mitambo iliyotumika inaweza kufanyiwa maboresho madogo au makubwa kabla ya kuanza kutumika tena.

v) Kuendana kwa bei ya mashine au mitambo iliyotumika na hali ya utendaji kazi wa mashine au mitambo hiyo. Bidhaa ambazo bado zipo katika hali nzuri ya kuweza kutumika pasipo kufanyiwa maboresho makubwa zitakuwa na bei kubwa kuliko zile ambazo hazitumiki kabisa kwa sababu ya ubovu.

vi) Kipindi cha udhamini (warranty period) kinachotolewa na mzalishaji au muuzaji wa mashine au mitambo iliyotumika ukilinganisha na mpya. Mashine au mitambo iliyotumika ambayo bado ina kipindi cha kutosha cha kuwa chini ya udhamini wa mzalishaji au muuzaji ni salama zaidi. Pale ambapo mashine au mitambo iliyotumika ilishamaliza kipindi cha udhamini, taasisi nunuzi inaweza kuomba kupewa kipindi kipya cha udhamini. Wazalishaji au wauzaji hutoa

kipindi kipya cha udhamini kwa masharti ya kuongeza bei, hivyo inapowezekana washindanishwe na wauzaji wengine.

vii) Kwa kuwa taasisi nunuzi inayohaki ya kujihakikishia ubora wa bidhaa kabla ya kuinunua au kuikodi masharti ya malipo yanayotolewa na mzalishaji au muuzaji hayatakiwi kumlazimisha mnunuzi kununua au kukodi pasipo ukaguzi.

Ushindani wa bei na masharti ya mkataba ni vema ufanyike baina ya wazalishaji na wauzaji mbalimbali ili kupata mtambo kwa bei sahihi na masharti yenye faida kwa mnunuzi.

B. Ubora wa mashine au mitambo iliyotumika

Kablaya ununuzi wabidhaa zilizotumika, taasisi nunuzi inapaswa kuainisha viwango vya ubora ambavyo mashine au mitambo iliyotumika inapaswa kuwa nayo ili iweze kufanya shughuli za usafirishaji ilizokusudiwa katika miundo mbinu iliyopo au itakayojengwa, kwa uzito, mwendo kasi, umbali na miezi au miaka inayotakiwa.

Ili kuhakisha mashine au mitambo iliyotumika ina viwango sahihi vya ubora taasisi nunuzi inapaswa:

i) Kumtaka muuzaji kuthibitisha pasipo shaka yoyote umri wa mashine au mitambo iliyotumika kwa kuwasilisha cheti kinachoonyesha nchi na mwaka ambao mashine au mitambo hiyo ilizalishwa kwa mara ya kwanza. Kwa kuwa kila mashine au mtambo wa usafirishaji una muda wake wa juu kabisa wa matumizi, taarifa ya umri wa mashine au mtambo tangu umezalishwa itasaidia kufahamu umri

uliobaki kufikia mwisho wa matumizi.

ii) Kumtaka muuzaji kuthibitisha kuwa teknolojia inayotumika katika kuendesha mashine au mtambo uliotumika bado inafanya kazi na iko sokoni. Iwapo teknolojia imeshapitwa na wakati, taasisi nunuzi ijiridhishe kama kuna uwezekano wa kufanya maboresho ya kuondoa teknolojia ya zamani na kuweka mpya.

iii) Kumtaka muuzaji kuwasilisha kumbukumbu zote za matengenezo ya kawaida na makubwa yaliyofanyika kwenye mashine au mtambo uliotumika. Kumbukumbu hizi zitasaidia kufahamu historia kamili ya matatizo ya kiufundi na utatuzi wake kama ulisaidia mashine au mtambo kuwa katika hali nzuri. Mashine au mitambo iliyofanyiwa maboresho makubwa mengi katika kipindi cha awali cha matumizi yake inaashiria ubovu na itahusisha gharama kubwa za uendeshaji.

iv) Kuhakikisha kuwa vipuri vinaweza kupatikana kutoka kwa mzalishaji wa mashine au mtambo uliotumika kwa kipindi chote ambacho utakuwa ukitumika. Iwapo vipuri halisi havipatikani ni vizuri kuangalia kama vipuri mbadala vinapatikana na vikitumika vitafanya mashine au mtambo ufanye kazi kwa ufanisi unaotakiwa.

v) Kumtaka muuzaji kuwasilisha cheticha ubora wa mashine au mitambo iliyotumika kinachotambuliwa na

mamlaka za kimataifa au kitaifa.

vi) Ukaguzi wa mashine au mitambo iliyotumika unafanywa na wataalam wa mashine au mitambo husika kabla na baada ya kusafirisha mtambo husika, ikiwezekana ukaguzi ufanywe na wakaguzi wa kujitegemea. Ni wazi matokeo chanya ya ukaguzi ndiyo yatapelekea taasisi nunuzi kununua mtambo husika.

Taasisi nunuzi inapaswa kuhakikisha kuwa mzalishaji au muuzaji wa mashine na mitambo iliyotumika ana sifa na uwezo mzuri kibiashara, kisheria na kiufundi kabla ya kuingia naye mkataba wa ununuzi.

Mchakato wa kuomba ruhusa ya Waziri wa Fedha na Mipango

Taasisi nunuzi hawaruhusiwi kununua au kukodi mashine au mitambo iliyotumika bila ya ruhusa ya Waziri wa Fedha na Mipango.

Ruhusa itaombwa kupitia fomu maalum iliyotengenezwa na PPRA; pamoja na kujaza fomu hiyo taasisi nunuzi itaambatanisha andiko la sababu za kutaka kununua mashine au mitambo iliyotumika na uthibitisho wa ubora wa mitambo au mashine husika.

Ili kufanya maamuzi sahihi ya kutoa au kutotoa ruhusa, Waziri wa Fedha ataunda kamati ya ushauri wa kiufundi isiyopungua wajumbe watatu na kuzidi saba ambao wana ujuzi na uzoefu wa mitambo au mashine husika.

Kamati ya ushauri wa kiufundi itafanya kazi kwa mujibu wa taratibu na hadidi za

rejea zitakazotolewa na Waziri.

Kamati itapaswa kupitia andiko la taasisi na nyaraka za uthibitisho wa ubora kisha kujiridhisha juu ya ukweli wa mambo yote kwa kutumia utaalamu wao au wengine wa kitaifa na kimataifa. Ili kujiridhisha wataalam wanapaswa kutembelea mahali ilipo mashine au mitambo iliyotumika na kufanya uchunguzi na majaribio yote ya kiufundi ili kujiridhisha juu ya ubora wake.

Ndaniyasiku 14 tangu kukamilisha zoezi la kujiridhisha, kamati itapaswa kuandaa na kuwasilisha ripoti yenye mapendekezo au ushauri kwa Waziri wa Fedha na Mipango. Ushauri na mapendekezo yanapaswa kumueleza Waziri kama atoe au asitoe ruhusa ya kununua au kukodi mashine au mitambo iliyotumika.

Waziri pia amepewa siku 14 tangu kupokea ripoti ya kamati kutoa maamuzi ya kuruhusu au kukataa ununuzi wa mashine au mitambo iliyotumika.

Baada ya kupata ruhusa ya waziri, taasisi nunuzi inapaswa kufuata mchakato wa ununuzi wa kawaida au wa dharura ili kununua mashine au mitambo iliyotumika. Taratibu hizo hujumuisha maandalizi ya nyaraka za zabuni, utangazaji wa zabuni, kufanya tathmini, kuthibitisha uwezo wa mzabuni (post qualification), kufanya majadiliano, kupekua na kusaini mkataba wa ununuzi na mwisho kusimamia utekelezaji wa mkataba.
