PUBLIC NOTICE

Pursuant to Section 72 of the Public Procurement Act, Cap 410, the Authority is empowered to debar firms or individuals from participating in public procurement activities and to inform procuring entities and the general public accordingly. In line with the above provisions, the **GENERAL PUBLIC** is hereby informed that the Authority has debarred two (2) firms, namely M/s Gopa Contractors Tanzania Limited and M/s RJ Mussa Construction Company Limited, from participating in public procurement and the disposal of public assets for a period of one (1) year, effective from 30th December 2025, for committing fraud (forgery).

The Ministry of Health (MoH) advertised tender Nos. 52/2024/2025/W/31 for the Proposed Construction of Neonatal Intensive Care Unit (NICU) at Dodoma RRH-TMCHIP and 52/2024/2025/W/42 for the Proposed Construction of Neonatal Intensive Care Unit (NICU) at Songea RRH- TMCHIP. In both tenders, each tenderer was required to submit a tender security of 300,000,000 Shillings and a demonstration of source of funds/line of credit worth 5,000,000,000 Shillings. In fulfilling these tendering conditions, the said firms forged and submitted tender securities and lines of credit from Guaranty Trust Bank (Tanzania) Limited.

Following the issuance of the debarment order, procuring entities and the general public are hereby **NOTIFIED** that all persons who were involved in the management affairs of the aforesaid companies at the time of debarment, as directors, partners, agents or officers, are also not allowed to participate in public procurement or the disposal of public assets by tender for the same periods. Pursuant to the provisions of Section 72 (8) of Cap 410, such directors, partners, agents or officers are not allowed to incorporate any company or entity for the purposes of supplies, civil works, consultancy and non-consultancy services.
