PUBLIC NOTICE

Pursuant to Section 62 (1) of Public Procurement Act, Cap. 410 and Regulation 99 of Public Procurement Regulations, 2013, as amended, the Authority is mandated to debar a firm or an individual from participating in public procurement proceedings and notify all procuring entities on such action. In the exercise of such powers, the Authority has debarred **M/s Modern Agrico Ltd** and its directors namely; **Hamud Mohamed Hamud, Masqud Khalid Said AI Esry, Warda Soud Amour** and **Japhary Juma Majilanga** from participating in public procurement for a **period of Five (5) Years commencing from 14**th **December 2023 to 13**th **December 2028** for failure to implement a Procurement Contract No. AE/092/2022/2023/KG/W/15 for rehabilitation of Roads at Ilagala and Buhingu Division in Uvinza District signed between TARURA-KIGOMA and the Company.

This is to inform the public that, any person who, at the time of debarment, was concerned with the management of the affairs of the debarred company as director, partner, agent or an officer are also not allowed to participate in public procurement or disposal by tender for the same period pursuant to Section 62(11) of the Public Procurement Act, Cap.410 read together with Regulation 101(3) of the Public Procurement Regulations, 2013 as amended.
