PUBLIC NOTICE

Pursuant to Section 72(1) of the Public Procurement Act No. 10 of 2023, the Authority is mandated to debar a firm or an individual from participating in public procurement and inform procuring entities and the general public to that effect. Based on the foregoing provisions, the Authority has debarred M/s Said Civil Engineering Contractors Ltd (including their directors, partners and agents) for a period of five (5) years and M/s Madema Company Limited and M/s Kapemala Engineering & General Traders Ltd (including their directors, partners and agents) for a period of ten (10) years from participating in public procurement from 18th June, 2024 to 17th June, 2029 and 18th June, 2024 to 17th June, 2034 respectively on the ground of fraudulent acts (forgery).

The three (3) companies participated in Tender Nos. No. AE.092/WC-RISE-P164920/379001/2023/24/W/01 for Construction of Box Culverts and Approach Roads along Nzega Town and Nzega District Roads in Tabora Region and AE.092/WC-RISE-P164920/379060/2023/24/W/01 for Construction of Box Culverts, Approach roads and rise Embarkment along Uyui, Sikonge and Kaliua District roads in Tabora Region which TARURA Tabora advertised for the Financial Year 2023/24. During tendering, the companies mentioned above submitted letters showing that they had registered Joint Venture Agreements with the Contractors Registration Board, Southern Zone, a false fact.

Following the issuance of the debarment order, procuring entities and the general public are hereby notified that all persons who were involved in the management of affairs of the companies mentioned above at the time of debarment as director, partner, agent or officer are also not allowed to participate in public procurement or disposal by tender for the same periods. Also, pursuant to the provisions of Section 72 (8) of the Public Procurement Act, No. 10 of 2023, such director, partner, agent or officer is not allowed to



incorporate any company or entity for purposes of supplies, civil works, consultancy and non-consultancy services.
